**PUBLIC HEARING & ADOPTION**

**AN ORDINANCE OF THE BOROUGH OF ENGLISHTOWN  
AMENDING & SUPPLEMENTING CHAPTER 2.50 OF THE BOROUGH  
CODE BOOK ENTITLED “SCHEDULE OF FEES”**

**BE IT ORDAINED** by the Governing Body of the Borough of Englishtown that the following sections be amended/supplemented as follows:

**Chapter 2.50, Schedule of Fees  
Section 2.50.02 – Recreation Fees**

**Annual Festival**

Festival Rides: ~~\$1.00 ea. Ride of 7 rides for \$5.00 or \$10.00 for unlimited rides.~~

Tickets: \$1.00 each or 10 for \$8.00  
Each ride is 2 tickets.

Bracelet: \$15.00 each or 2 for \$25.00  
Unlimited rides

**Annual Halloween Party**

Entrance Fee: ~~\$2.00~~ \$3.00 per person  
(children 10 yrs. and under are free)

**Annual Holiday Hayride**

Ride Fee: ~~\$3.00~~ \$5.00 per person  
(children 10 yrs. and under are free)

**Farmers Market:**

Vendor Fee: Englishtown Resident: \$20.00  
Non-Resident: \$25.00

This ordinance shall take effect upon final passage and publication according to law.
