- The Department will be participating in the year end Drive Sober or Get Pulled Over Holiday Crackdown Campaign. This is 100% Federally funded.
- Federal & State Grant money has been awarded the department for replacement vests for four officers. The cost of the vests are \$1,170.00 each.
- Our Class II position is still open. Two candidates have accepted employment elsewhere. A large number of candidates are still interested in the position.
- One of our Patrol Cars has serious engine problems and is too costly to repair. Our older model Fords are mostly used for road jobs.
- The Police Department has received from the Englishtown Fire Department a 2002 Ford Pick-up Truck with low mileage and already equipped with emergency lighting. This vehicle and be used in emergencies or for road jobs which will help to eliminate wear and tear on the Police Patrol Cars.

John Hogan 70 Carriage Lane wants to know when Carriage Lane will be paved? Mayor Reynolds replies asphalt companies are closed they will be open in the Spring and that's when it will be done. Also when will the water / mosquito issue be addressed? Mayor Reynolds replies a slow process we will inquire as to when this will be addressed.

Rob Lancsak 20 Harrison Avenue update from Mayor Reynolds has spoken to the owner and he is seeking out an insulation expert on sound proofing of the studio.

Jim Lacugna 15 Harrison Avenue said the noise of the Air Conditioner replaced at the Verizon Building 17 Harrison is excessively loud and would like it to be addressed. Mayor Reynolds said we will look into it.

C/Wojyn at this time would like to commend the Village Inn on their pursuit of a grant to paint the building. Mayor Reynolds asked if perhaps another council meeting can be held there? This will be addressed.

- 8. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of performance of, promotion or disciplining of any specific prospective public officer or employee or current public officer or employee, employed or appointed by the public body;
- 9. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit; and

WHEREAS, N.J.S.A. 10:4-13 provides that a public body may not exclude the public from any meeting to discuss any matters described in N.J.S.A. 10:4-12 until the public body has adopted a resolution at a meeting to which the public shall be admitted, stating the general nature of the subject to be discussed and stating as precisely as possible, the time and when the circumstances under which the discussion conducted in a closed session of the public body can be disclosed to the public; and

WHEREAS, the Mayor and Council of the Borough of Englishtown believe that a closed session pursuant to Sections 5, 6, and 7 of N.J.S.A. 10:4-12b is required to discuss personnel, and MacInnes litigation.
