There was a moment of silence and salute to the flag.

Presentation: 2018 Audit by Robert Allison of Holman, Frenia & Allison

Mr. Robert Allison discussed three (3) separate audits done in connection with the Independent Auditor's Report; that being the Management's Responsibility, the Auditor's Responsibility and the Internal Controls. He commented that the Borough received a rating of an "unmodified report" with a clean opinion. There were no internal control deficiencies and No Recommendations & Findings. The new Accounting Principle, GASB #75 was mentioned.

Mr. Allison went over the Fund Balances for Current, Water and Sewer. Noted that the Current and Sewer Funds have healthy balances, while the Water Fund is at 47% of its budget, however declining during the past several years. It was suggested that an analysis of the department be done on future needs and if additional monies are needed to cover rising expenses. Within the General Capital Fund it was noted that there were several ordinances that needed to be funded and recommended financing them, and within the Court, it was mentioned that old outstanding checks should be cleaned up.

He thanked Mayor and Council for allowing the firm to serve the Borough.

- 9. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit; and

WHEREAS, N.J.S.A. 10:4-13 provides that a public body may not exclude the public from any meeting to discuss any matters described in N.J.S.A. 10:4-12 until the public body has adopted a resolution at a meeting to which the public shall be admitted, stating the general nature of the subject to be discussed and stating as precisely as possible, the time and when the circumstances under which the discussion conducted in a closed session of the public body can be disclosed to the public; and
