**RESOLUTION APPROVING THE BOROUGH OF ENGLISHTOWN REVISED
STORMWATER CONTROL ORDINANCE**

Charles Casagrande offers the following Resolution and moves its adoption:

WHEREAS, Monmouth County Planning Board Resolution No.04-08 of February 17, 2004 created the Stormwater Technical Advisory Committee that serves as an advisory committee to the Monmouth County Planning Board in its review of stormwater management plans and stormwater control ordinances consistent with N.J.A.C 7:8; and

WHEREAS, in accordance with N.J.A.C. 7:8, as amended on March 2, 2020, all municipal stormwater control ordinances (SCOs) must be revised and be effective by March 3, 2021; and

WHEREAS, the Stormwater Technical Advisory Committee met on September 1, 2021 and reviewed the revised stormwater control ordinance submitted by the Borough of Englishtown; and

WHEREAS, the Stormwater Technical Advisory Committee at the September 1, 2021 meeting found the ordinance to be consistent with N.J.A.C. 7:8, as amended, and recommended that the Borough of Englishtown revised stormwater control ordinance be approved; and

WHEREAS, the Monmouth County Planning Board has reviewed and discussed the recommendation of the Stormwater Technical Advisory Committee.

NOW, THEREFORE, BE IT RESOLVED that the Monmouth County Planning Board does hereby grant final and unconditional approval of the Borough of Englishtown stormwater control ordinance.

BE IT FURTHER RESOLVED that certified true copies of this Resolution be forwarded to the Monmouth County Planning Board's Stormwater Technical Advisory Committee and the Borough of Englishtown.
