A. Bench Dedication in Memory of Councilmember Rudy Rucker

B. Brush Collection

Mayor Reynolds stated that the Borough normally collected brush after large storms, but now some residents are clearing lots and expecting the Borough to collect the brush cleared. This causes Englishtown to experience high fees for dumping the brush. Effective July 1, due to costs, the borough will no longer be collecting brush unless after a storm. A notice will go out to residents with utility bills. Mayor Reynolds will also speak to Monmouth County on the matter, regarding services they may provide. Obtaining a chipper was also discussed as a possibility

C. OPRA Records Custodians

The governing body discussed a recent lawsuit filed against the Borough with regard to the handling of an OPRA request. Attorney Youssouf gave further explanation of the specifics of the suit. Committee Reports:

Councilmember Francisco- Code Enforcement, Public Health, Welfare & Public Events Reported on a matter of a fence being down on Victory Drive, to the rear of properties on McDonald Way, that appears to be on Borough property. Mayor Reynolds indicated that there is a similar situation with a fence on Hospitality Way that raises questions as to who installed the fence and who now owns the fence, therefore responsible to maintain

Councilmember Lewis- Public Utilities

Reported on the water/sewer permits for allocation 10-year renewal proposal submitted to the N.J.D.E.P. for phase 2. Water Quality Accountability Act submittal is in progress. Proactive sewer cleaning took place on Water and Main Street. The missing light pole has been replaced on Heritage Drive. Trying to get clarification on bulk pick-ups as not clear. Will wait until get information in writing.

Council member Marter- Legislative, Insurance and Licenses Had no report.

Councilmember Mann- Public Safety

Read the April monthly police report. Reminded everyone of the currently ongoing Click-It-or-Ticket campaign.

Councilmember Robilotti- Administration, Finance and Personnel.

Reported that on May 19th, the free rabies clinic was held. Councilmember Robilotti volunteered her time to assist with the clinic, saving the town 50 dollars. Approximately 20 residents were in attendance. The Monmouth County health inspector did not show. From what we were told he had a family emergency. Very special thanks were given to Dr. Kwacz and her tech for saving the day. She went and got her serum and sharps and was able to inoculate the animals in attendance. Without her we really would've had a very bad situation. She truly was our HERO!!!!

The planning board last night held their meeting and the board approved application 2022-03B for a deck and 2021-01 for final site plan for the industrial park. Mayor Reynolds spoke regarding the planning board meeting and the inability of the board to disapprove the application for the industrial park as it had previous preliminary approvals. Traffic patterns in the area were also discussed to hopefully alleviate heavy traffic in the residential area by the industrial park.

Councilmember Wojyn- Public Buildings & Grounds, Technology Reported that 370+ users are signed up on the Borough website and he is currently looking into using a webmaster for the site. The "get-in-touch" portion of the website is receiving a lot of spam. Councilmember Marter stated costly programs would be needed to eliminate the spam being received. Ordinance No. 2022-02 – Public Hearing & Adoption

Ordinance Authorizing a Special Emergency Appropriation Pursuant to N.J.S.A. 40A:4-53(D) for the Preparation of a Revision and Codification of the Ordinances of the Borough of Englishtown, County of Monmouth, New Jersey.

WHEREAS, N.J.S. 40A:4-53(d) provides for a municipality to adopt by ordinance special emergency appropriations for the preparation of a revision and codification of the municipal ordinances; and,

WHEREAS, the estimated cost of the engagement of special consultants for the preparation of a revision and codification of the municipal ordinances is \$18,390.00;

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Englishtown, County of Monmouth and State of New Jersey as follows:

- 1. In accordance with N.J.S.A. 40A:4-53(d) a special emergency appropriation is hereby authorized for the purpose of carrying out the code review and revision of the Borough of Englishtown as mandated by N.J.S.A. 40:55D-89 and shall be deemed a special emergency appropriation in the amount of \$18,390.00.
- 2. That authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of not less than \$3,678.00, reflecting at least one-fifth of the total amount authorized by this ordinance and as provided in N.J.S.A. 40A-55(c).
- 3. A copy of this ordinance shall be filed with the Director of the Division of Local Government Services five (5) days after final passage.
- 4. This ordinance shall take effect upon final passage and publication as required by law.
- 5. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Ordinance No. 2022-05 – Public Hearing & Adoption

An Ordinance of the Borough Council of the Borough of Englishtown Prohibiting Smoking in Public Locations in the Borough and Amending Part II, "General Legislation", of the Code of the Borough of Englishtown by Repealing Existing Chapter 2.110 Entitled, "Smoking in Municipal Buildings" in its Entirety and Adding Thereto a New Chapter 2.110 "Smoking Regulations"

WHEREAS, The Borough Council hereby finds and determines that:

a. The smoking of tobacco products is a major contributor to air pollution and that breathing in secondhand smoke is a cause of disease to nonsmokers;

- b. The United States Department of Environmental Protection (EPA) has designated secondhand smoke as a Class A carcinogen, as well as a significant cause of respiratory problems in children;
- c. In 1986 the United States Surgeon General found that the active smoking of tobacco products and the passive inhalation of environmental tobacco smoke are the most prevalent causes of preventable death, disease and disability;
- d. The New Jersey Legislature found and declared that tobacco is the leading cause of preventable disease and death in the State of New Jersey and the nation and tobacco smoke constitutes a substantial health hazard to the nonsmoking majority of the public;
- e. The Borough Council has determined that the public interest is especially implicated to prevent the youth of Englishtown Borough from being exposed to harmful smoke and being near the temptations of experimental tobacco and cannabis products;
- f. In 2006, the Legislature enacted the New Jersey Smoke Free Air Act, N.J.S.A. § 26:3D-55 et seq., creating an outright ban on smoking in virtually all public indoor facilities and extending such ban to the grounds of any public or nonpublic elementary or secondary school, regardless of whether the area is an indoor or outdoor public place and expanded same in 2019 to include public beaches and parks; and
- g. The Legislature has deemed the control of smoking to be a necessary and proper exercise of municipal authority pursuant to N.J.S.A. 40:48-1 et seq., 40:48-2 et seq., and N.J.S.A. 2C:33-13 for the preservation of public health, safety and welfare of the community.

NOW, THEREFORE, BE IT ORDAINED, by the Borough Council of the Borough of Englishtown, County of Monmouth, in the State of New Jersey, as follows:

SECTION ONE. The Code of the Borough of Englishtown, Part II, "General Legislation", be and the same is hereby amended and supplemented to add thereto the following Chapter:

"Chapter 2.110. SMOKING REGULATIONS.

§ 2.110.01 Definitions.

The following words, terms and phrases, when used in this Chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

- A. "Electronic smoking device" means an electronic device that can be used to deliver nicotine or other substance such as cannabis product to the person inhaling from the device, including, but not limited to, an electric cigarette, cigar, cigarillo, or pipe.
- B. "Enclosed area" shall mean all areas between a floor and a ceiling, extending to the outer perimeter walls of a structure.
- C. "Indoor public place" means a structurally enclosed place of business, commerce or other service-related activity, whether publicly or privately owned or operated on a for-profit or nonprofit basis, which is generally accessible to the public, including, but not limited to: a commercial or other office building; office or building owned, leased or rented by the State or by a county or municipal government; public and nonpublic elementary or secondary school building; board of education building; theater or concert hall; public library; museum or art gallery; bar; restaurant or other establishment where the principal business is the sale of food for consumption on the premises, including the bar area of the establishment; garage or parking facility; any public conveyance operated on land or water, or in the air, and passenger waiting rooms and platform areas in any stations or terminals thereof; health care facility licensed pursuant to P.L.1971, c. 136 (C.26:21-1-1 et seq.); patient waiting room of the office of a health care provider licensed pursuant to Title 45 of the Revised Statutes; child care center licensed pursuant to P.L.1983, c. 492 (C.30:5B-1 et seq.); race track facility; facility used for the holding of sporting events; ambulatory recreational facility; shopping mall or retail store; hotel, motel or other lodging establishment;

apartment building lobby or other public area in an otherwise private building; or a passenger elevator in a building other than a single-family dwelling.

D. "Park and recreational facilities" shall include any and all athletic fields, public parks, playgrounds, ball fields and other active and passive recreation areas primarily of service to youth, owned, leased, operated or under the ownership control of the Borough of Englishtown to which the general public is invited and youth under the age of 18 may gather for recreational activities, including all areas adjacent to such facilities, including, but not limited to, any parking area, driveway or drive aisle.

E "Person" means any individual, partnership, cooperative association, private corporation, personal representative, receiver, trustee, assignee or any other legal entity.

F. "Public Building" means any building, structure, facility or complex, including but not limited to appurtenant parking areas, public street, roadway, thoroughfare, sidewalk, bridge, alley, plaza, swimming pool, shopping mall, plaza, public transportation facility, public library, vehicle used for public transportation owned, leased, operated or under the ownership control of the Borough of Englishtown to which the general public is invited.

G "Smoking" means burning of, inhaling from, exhaling the smoke from, or the possession of a lighted cigar, cigarette, pipe, hookah or similar device, or any other device which contains tobacco, cannabis, or any other matter that can be smoked, or the inhaling or exhaling of smoke or vapor from an electronic smoking device.

H. "Workplace" means a structurally enclosed location or portion thereof at which a person performs any type of service or labor.

§2.110.02 Restrictions.

- A. Smoking shall be prohibited by any person, regardless of age, in all public parks, playgrounds and recreation facilities owned or leased by the Township (sic), including that land upon which the public is invited or upon which the public is permitted and where individuals gather for recreation activities and all areas adjacent to such facilities, including, but not limited to, parking areas, driveways or drive aisles, which have been designated by no-smoking signs and which are hereafter designated as "Smoke and Tobacco Free Places."
- B. Smoking shall be prohibited by any person, regardless of age, in any indoor public place, public building or workplace within the Borough and all areas adjacent to such facilities, including, but not limited to, parking areas, driveways or drive aisles, which have been designated by no-smoking signs and which are hereafter designated as "Smoke and Tobacco Free Places".

§ 2.110.03 Signs.

Signs shall be clearly, sufficiently, and conspicuously posted where smoking is prohibited by this Chapter. The signs shall state "NO SMOKING," and/or contain the international no-smoking symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle with a diagonal red line through its cross section). The signs shall be clearly visible to the public and shall contain letters or a symbol which contrasts in color with the sign, indicating that smoking is prohibited in the designated area. The sign shall also indicate that violators are subject to a fine.

§ 2.110.04 Enforcement.

Page 11 of 27

The Englishtown Police Department, Fire Department, Recreation Department, Public

Works Department, Health Department and any municipal officer charged with code

enforcement is hereby charged with enforcement of this Article. Further, the person

having control over an indoor public place or workplace shall order any person smoking in

violation of this section to comply with the ordinance. "

SECTION TWO. All Ordinances or parts thereof inconsistent with the provisions

of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION THREE. Should any section, paragraph, clause or other portion of this

Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment

shall not affect or impair the remainder of this Ordinance.

SECTION FOUR. This Ordinance shall take effect upon its passage and publication

according to law.

Ordinance No. 2022-06 – Introduction

Bond Ordinance Amending and Supplementing Bond Ordinance Number 2021-05 (Which Provides for Improvements to the Englishtown Lake Dam) Heretofore Finally Adopted by the Borough Council of the Borough of Englishtown, in the County of Monmouth, State of New Jersey, on August 25, 2021, to Increase the Appropriation by \$65,250

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ENGLISHTOWN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The bond ordinance of the Borough of Englishtown, in the County of Monmouth, State of New Jersey (the "Borough"), heretofore finally adopted by the Borough Council thereof on August 25, 2021, numbered 2021-05 and entitled, "BOND ORDINANCE PROVIDING FOR IMPROVEMENTS TO THE ENGLISHTOWN LAKE DAM, BY AND IN THE BOROUGH OF ENGLISHTOWN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$750,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$712,500 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF" (the "Original Ordinance"), which Original Ordinance is hereby amended and supplemented, as follows:

SECTION 2. For the improvements or purposes set forth in Section 3(a) of the Original Ordinance, as amended and supplemented hereby, there is hereby appropriated the additional sum of \$65,250 to reflect the award of grant monies received or expected to be received from the County of Monmouth. The total appropriation of the Original Ordinance, as amended and supplemented hereby, is increased by \$65,250, from \$750,000, and is equal to \$815,250.

- **SECTION 3**. (a) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose set forth in the Original Ordinance, as amended and supplemented hereby, is equal to and remains unchanged at \$712,500.
- **(b)** The estimated cost of the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby, is equal to \$815,250.
- **SECTION 4.** The Capital Budget of the Borough is hereby amended, as necessary, to conform with the provisions of this amendatory and supplemental bond ordinance and to the extent of any inconsistency herewith, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs (the "Director of the Division of Local Government Services"), will be on file in the office of the Clerk and will be available for public inspection.
- **SECTION 5.** For the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby, the additional sum of \$13,050 is hereby included for the items of expense listed in and permitted under N.J.S.A. 40A:2-20, making the total amount for such items of expense \$363,050, such total amount being included in the estimated cost indicated herein for the improvements or purposes set forth in the Original Ordinance, as amended and supplemented hereby.

SECTION 6. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption and approval by the Mayor, as provided by the Local Bond Law.

Ordinance No. 2022-07- Introduction

Bond Ordinance Providing for Various Road Improvements, by and in the Borough of Englishtown, in the County of Monmouth, State of New Jersey; Appropriating \$825,000 Therefor (Including Grants from the New Jersey Department of Transportation in the Aggregate Amount of \$602,800) and Authorizing the Issuance of \$180,950 Bonds or Notes of the Borough to Finance Part of the Cost Thereof

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ENGLISHTOWN, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements or purposes to be undertaken by the Borough of Englishtown, in the County of Monmouth, State of New Jersey (the "Borough"). For the said improvements or purposes stated in Section 3, there is hereby appropriated the sum of \$825,000, which sum includes grants from the New Jersey Department of Transportation in the aggregate amount of \$602,800 (\$270,000 allocable to Conover Street, Park Avenue and Station Street improvements, \$212,800 allocable to Lasatta Avenue and Mt. Vernon Road improvements, and \$120,000 allocable to W. Dey Street improvements, further details of which are set forth in Section 3(a) hereof) (collectively, the "Grants") and \$41,250 as the amount of down payment for said improvements or purposes as required by the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "Local Bond Law"). Said down payment is now available therefor by virtue of an appropriation in a previously adopted budget or budgets of the Borough for down payment or for capital improvement purposes.

SECTION 2. For the financing of said improvements or purposes described in Section 3 hereof and to meet the part of said \$825,000 appropriation not provided for by application hereunder of the Grants and down payment, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$180,950 pursuant to the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Borough in a principal amount not exceeding \$180,950 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

- **SECTION 3.** (a) The improvements hereby authorized and purposes for the financing of which said bonds or notes are to be issued are various road Improvements by and in the Borough including, but not limited to, Conover Street, Park Avenue, Station Street, Lasatta Avenue, Mt. Vernon Road and W. Dey Street, said improvements to include, but not be limited to, excavation, milling, paving, reconstruction, boxing out, and resurfacing or full depth pavement replacement, and, as applicable, the repairing and/or installation, of associated curbs, curb ramps (including ADA compliance), sidewalks and driveway aprons, drainage work, roadway painting, landscaping and aesthetic improvements and traffic control; and also including all engineering and design work, surveying, construction planning, preparation of plans and specifications, permits, bid documents, construction inspection and contract administration, and all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.
- (b) The estimated maximum amount of bonds or notes to be issued for said improvements or purposes is \$180,950.
- (c) The estimated cost of said improvements or purposes is \$825,000, the excess amount thereof over the said estimated maximum amount of bonds or notes to be issued therefor are the Grants in the aggregate amount of \$602,800 and the down payment for said purpose in the amount of \$41,250.

SECTION 4. Except for the Grants, in the event the United States of America, the State of New Jersey, the County of Monmouth and/or a private entity make a contribution or grant in aid to the Borough, for the improvements and purposes authorized hereby and the same shall be received by the Borough prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received from the United States of America, the State of New Jersey, the County of Monmouth and/or a private entity. Except for the Grants, in the event, however, that any amount so contributed or granted by the United States of America, the State of New Jersey, the County of Monmouth and/or a private entity, shall be received by the Borough after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose. This Section 4 shall not apply, however, with respect to any contribution or grant in aid received by the Borough as a result of using funds from this bond ordinance as "matching local funds" to receive such contribution or grant in aid.

SECTION 5. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Borough, provided that no note shall mature later than one (1) year from its date unless such bond anticipation notes are permitted to mature at such later date in accordance with applicable law. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, and the maturity schedule of the notes so sold, the price obtained and the name of the purchaser.

SECTION 6. The Capital Budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency, a resolution in the form promulgated by the Local Finance Board showing full detail of the amended Capital Budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs will be on file in the office of the Clerk and will be available for public inspection.

SECTION 7. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses and are improvements which the Borough may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The average period of usefulness of said improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is 20 years.

- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Borough and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$180,950 and the said bonds or notes authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- (d) An aggregate amount not exceeding \$200,000 for items of expense listed in and permitted under section 20 of the Local Bond Law is included in the estimated cost indicated herein for the improvements or purposes hereinbefore described.
- **SECTION 8.** The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the bonds or notes authorized by this bond ordinance. The bonds or notes shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the bonds or notes and the interest thereon without limitation as to rate or amount.
- **SECTION 9.** The Borough hereby declares the intent of the Borough to issue the bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use proceeds to pay or reimburse expenditures for the costs of the purposes described in Section 3 of this bond ordinance. This Section 9 is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.
- **SECTION 10.** The Borough Chief Financial Officer is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The Borough Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.
- **SECTION 11.** The Borough covenants to maintain the exclusion from gross income under section 103(a) of the Code of the interest on all federally tax-exempt bonds and notes issued under this ordinance.
- **SECTION 12.** This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adoption and approval by the Mayor, as provided by the Local Bond Law.

WHEREAS; Upon due consideration of the merits of the claim, the Borough has concluded that settlement of the claim is in the best interests of the Borough of Englishtown; and

WHEREAS; Pursuant to a negotiated settlement, the Borough has produced and forwarded all requested records to Plaintiff and has agreed to pay a proportionate legal fee to plaintiff's counsel.

NOW, THEREFORE be it hereby resolved by the Mayor and Council of the Borough of Englishtown that the settlement of the claim asserted in the above specified litigation is approved and payment authorized to plaintiff's counsel of legal fees and costs, a copy of which is annexed hereto and incorporate herein by reference.
