Meeting Called to Order and Roll Call

The meeting was called to order by Mayor Reynolds at 6:32 pm.

Discussion Items:

Best Practices Inventory Worksheet
 Finance Officer Sylvia Eryan-Hawileh and Deputy Finance Officer Laurie Finger reported and
 fielded inquiry on the answers to be provided for questions on the Best Practices Worksheet
 regarding Englishtown Borough. Some of the question topics included the Borough website, cyber
 security and electric vehicle charging stations. Englishtown has sufficient points to receive 100%
 state aid.

• Cannabis Ordinance 2022-012

Mayor Reynolds described the survey sent to residents in 2021, only a quarter of which were returned. The majority of those surveys were against cannabis businesses in town. Mayor Reynolds gave history of the current cannabis ordinance decision and suggested a referendum question be placed on the ballot in 2023, allowing the residents to determine what is wanted by them. Borough Attorney Youssouf urged that the Unified Planning/Zoning Board be given the opportunity to provide input at their November meeting on the 6 cannabis classes to be allowed in the Borough. Mayor Reynolds indicated that he will contact the Borough Engineer, Planning Board Attorney and Board Secretary on the matter.

Review of Professional Services Contracts – Councilmember Francisco
 Mayor Reynolds stated that current professional rates have been provided to Council as requested.
 The rates are not exorbitant. Borough professionals are appointed annually and requests for
 proposals would need to be prepared should Council decide to go that route. Councilmembers Lewis
 and Francisco inquired on the amounts spent annually for professionals and whether contracts

automatically renew. The annual costs for Borough professionals are to be provided to Council for discussion at the November Council meeting.

- Formation of Recreation Committee Councilmember Francisco
 Borough Attorney Youssouf gave explanation on committees versus commissions and after further
 discussion an advisory ad hoc recreation committee was agreed upon. Councilmember Francisco
 named three persons who have agreed to participate: Kim Reque, Nicole Fiore, and Kim Sabin.
- Recording of Council Meetings Councilmember Lewis
 Mayor Reynolds suggested that this matter be considered in 2023 so necessary equipment could be
 researched and included in the 2023 budget. Deputy Finance Officer Finger indicated that the
 equipment could be capitalized. Councilmember Lewis suggested looking into a shared service
 agreement with Manalapan Township. Mayor Reynolds said that he will reach out to Manalapan
 Township.
- Councilmember Salaries Councilmember Sabin Mayor Reynolds expressed his disagreement with changing Councilmember salaries as two of the current councilmember's terms are expiring on December 31 and it would be a disservice to make changes before the incoming members could decide for themselves. Councilmember Sabin stated that he made a motion at the previous meeting and expected the required ordinance to be included on the agenda for this meeting. Borough Attorney Youssouf spoke to required steps for ordinance introduction and adoption and the need for a written ordinance.
- Mayor Reynolds stated that he had received correspondence from the person that coordinates Town Planner Calendar. They are requesting dates for the Borough's usual events, like the Easter Egg Hunt, Halloween, the Memorial Day Parade, and the 9/11 Ceremony. The dates will need to be provided soon as their deadline for printing is approaching.

Ordinance No. 2022-012- Public Hearing, Second Reading

AN ORDINANCE REPEALING SECTION 2.130.09 "PROHIBITED USES" OF CHAPTER 2.130 "ZONING", AS AMENDED, OF THE CODE OF THE BOROUGH OF ENGLISHTOWN PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESS WITHIN THE BOROUGH OF ENGLISHTOWN

WHEREAS; The Borough Council adopted an Ordinance amending the Zoning Ordinance of the Borough of Englishtown pursuant to Section 31b. of P.L. 2021, c.16 the "New Jersey Cannabis Regulatory

Enforcement and Assistance and Marketplace Modernization Act" which permits municipalities to prohibit the application of the provisions of the "Act" by adoption of an Ordinance; and

WHEREAS; Upon due reconsideration, the Governing Body of the Borough has determined that the adoption of the ordinance prohibiting the application of the Act within the Borough should be repealed forthwith.

NOW, THEREFORE, IT IS HEREBY ORDAINED AS FOLLOWS:

ARTICLE 1: The ordinance amendment prohibiting the operation of all classes of Cannabis Businesses within the Borough of Englishtown is repealed in its entirety.

ARTICLE II: Any article, section, paragraph, subsection or provision of this Ordinance inconsistent with the provisions of this Ordinance amendment is hereby repealed to the extent of such inconsistency.

ARTICLE III: Should any article, section, paragraph, subsection, clause or provision of this ordinance amendment be adjudged invalid or unconstitutional by a court of competent jurisdiction such adjudication shall apply only to the section, paragraph, subsection, or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

ARTICLE IV: This ordinance shall take effect upon its passage and publication, publication with the Monmouth County Planning Board, and as otherwise provided by law.

Borough Attorney Youssouf advised that conditions of uses are not set and the Borough would need to deal with applicants on a case-by-case basis. Should the ordinance be repealed, the Borough has no control. Attorney Youssouf also described what would need to be done in order for a question to be placed on the ballot as suggested. The question would appear on the next general election ballot. Suggested structuring an ordinance to have some controls in place and currently there is no permitted zone. Attorney Youssouf urged the Borough follow procedure and refer this matter to the Unified Planning/Zoning Board, following the procedure he had outlined and to eliminate any questions of transparency.

Motion was made by C/Sabin, C/Lewis to eliminate Mayor and Council salaries effective January 1, 2023 with all present Councilmembers in favor of having an ordinance prepared for the next meeting.

Motion was made by C/Francisco, seconded by C/Lewis with all present Councilmembers in favor of having the Borough Attorney prepare an ordinance to lift the parking ban on both sides of Hamilton Street, Harrison Avenue and Irving Place after the Planning Board conveys their opinion.

Executive Session

RESOLUTION OF THE BOROUGH OF ENGLISHTOWN MAYOR AND COUNCIL FOR A CLOSED OR EXECUTIVE SESSION PURSUANT TO N.J.S.A. 10:4-13.

WHEREAS, N.J.S.A. 10:4-12B provides that a public body may exclude the public from that portion of a meeting at which the body discusses contract negotiations;

- 1. Any matter which, by express provision of Federal Law or State statute or rule of court, shall be rendered confidential;
- 2. Any matter in which the release of information would impair a right to receive funds from the Government of the United States;
- 3. Any material, the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records or personal material including health records, legal defense, insurance, etc.
- 4. Any collective bargaining agreement or terms and conditions related thereto;
- 5. Any matter involving the purchase, lease or acquisition or real property with public funds;
- 6. Any tactics and techniques utilized in protecting the public safety and property;
- 7. Any pending or anticipated litigation or contract negotiation wherein the public body is, or may become a party. Any matters, falling within the attorney-client privilege, to the extent that confidentiality is required.
- 8. Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of performance of, promotion or disciplining of any specific prospective public officer or employee or current officer or employee, employed or appointed by the public body.
- 9. Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or suspension or loss of a license or permit.

WHEREAS, N.J.S.A. 10:4-13 provides that a public body may not exclude the public from any meeting to discuss any matters described in N.J.S.A. 10:4-12 until the public body has adopted a resolution at a meeting to which the public shall be admitted, stating the general nature of the subject to be discussed and stating as precisely as possible, the time and when the circumstances under which the discussion conducted in a closed session of the public body can be disclosed to the public.

WHEREAS, the Mayor and Council of the Borough of Englishtown believe that a closed session pursuant to Section 4 of N.J.S.A. 10:4-12b is required to discuss falling within personnel matters.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the public be excluded from this portion of the public meeting convened this 26th day of October, 2022, pursuant to Section 4 of the Open Public Meetings Act.

BE IT FURTHER RESOLVED, that the subject matter of this executive session will be made public when it is no longer required that the subject matter discussed be kept privileged.
